## Sikh Council UK Welcomes Cabinet Office Enquiry and Calls for Full Disclosure

The Sikh Council UK welcomes the decision of the Prime Minister, David Cameron to ask the Cabinet Secretary to look into the issues behind the apparent disclosure of previously classified documents and to establish the facts.

In doing so the Sikh Council UK will continue to press for full disclosure of all papers and documents relating to UK Government actions and involvement in the 1984 attack by the Indian Army on the Golden Temple Complex including Sri Harmandir Sahib and Sri Akal Takhat Sahib, Amritsar and subsequent events.

Secretary General of the Sikh Council UK, Gurmel Singh said, "I am pleased the Prime Minister has recognised the deep felt hurt within the Sikh community and instructed urgent investigation by the Cabinet Secretary. The community has been shocked by these revelations and the Prime Minister will need to ensure that the entire truth of this distressing episode is revealed."

"The letters that have been revealed date from February 1984 yet the attack took place in June 1984 and then there was the subsequent genocide of Sikhs following Indira Gandhi's assassination in October 1984. The community wants to know what else were the UK Government saying and doing over all that time?"

Chair of Indian Sub-Continent Affairs Sub-Committee of Sikh Council UK, Cllr Gurdial Singh Atwal said, "As UK citizens and tax payers and as a largely law abiding community the undemocratic nature of the events described in these letters has really shocked us. We are though pleased that politicians of all parties have responded very quickly and are seeking answers on our behalf."
